


Do you have questions about boundary expansion? If so, what are they?




What change in services would you like to see?

35 responses total. NOTE: Any responses such as "not certain", "nothing as of now", and similar were deleted from this report.

- 1. 2nd Firehall along highway, sewer lines in all areas of Teslin.
- 2. Being hooked up to sewer services.
- 3. More animal control. Enforce speed control.
- 4. Septic pump outs from municipality, force main for dense areas.
- 5. Dog control, snow removal, sanding, and we can vote.
- 6. Street lights.
- 7. Animal control!
- 8. Affordable service piped water and better road care.

- 10. Future expansion (past current proposed).

My son does not take the school bus because it's way too dark for him to stand at the top of the highway. Big trucks do not slow down and they have slid going around the corner starting from Ted Lambert's, Tommy Dickson and my house. They also have tipped a bit from going too fast My son was almost hit last year standing up there waiting for the school bus. There are some pot holes close to the White line that need to be filled cause some trucks nail them and slid as well. Fox Point could use a few extra as well for street lights. what about sever

lines being installed? It would help a lot of people with pump outs and tank problems, plus the tanks flooding. Snow clearing as scrapers go by driveways leaving a lot of snow for people and homeowners/renters depending the area. Big windrows of hard chunky snow is becoming a problem for some people who still use shovels.
